Sheboygan County High School Mathematics Meet**

For the 11th straight year, Sheboygan North High School has won Lakeland College's Sheboygan County High School Mathematics Meet. The meet was held October 23, 2006.

Thirty-three teams consisting of more than 240 students from Cedar Grove-Belgium High School, Kohler High School, Oostburg High School, Sheboygan County Christian High School, Sheboygan North and Sheboygan South High School participated in the event.

Sheboygan North High School had fifty-six students which formed seven teams. Out of these seven teams, North High School had a fourth place finish as well. Individual winners also placed first, second third, and eighth in the event. Four Sheboygan North members were honorable mentions.

District E-Mail Use by Staff

As the use of e-mail becomes more and more a core part of doing our jobs as teachers and support staff, it is important that we remember a few things about using the district e-mail system.

Any e-mail messages that pass through the district's e-mail server are considered property of the district. Because of this, the district administrators have every right to examine any and all e-mail messages that you send or receive using your district e-mail account.

Secondly, any e-mail messages that pass through the district's e-mail server are subject to the Open Records Laws that govern public institutions. Any citizen of your community can request copies of your e-mail messages. If such a request is made, the district must comply.

As you would expect, there are exceptions to the Open Records Law. For example, messages that contain information that is considered confidential in nature (specifically, student information or employee personnel records) can be held back. Otherwise, copies of all e-mail messages will be released when a request is made to the district.
