## Membership

KMUC-Retired membership requires concurrent membership in WEAC-Retired and NEA-Retired. There are two enrollment options:

Option #1: Already retired individuals may join KMUC-Retired/WEAC-Retired/NEA-Retired with one payment for a life membership.

Life membership in KMUC-Retired/WEAC-Retired/NEA-Retired costs \$435 (\$375 WEAC/NEA-Retired + \$60 for KMUC-Retired).

To join, contact the chapter president or call the WEAC Membership office and request an Already Retired Enrollment Form or go online to [www.weac.org](http://www.weac.org) and click on Inside WEAC to find the retired site with a downloadable form.

Option #2: WEAC active members can save money by enrolling as a Pre-Retired Subscriber (prepaid life membership) in KMUC-Retired, WEAC-Retired and NEA-Retired *at any time prior to retirement*.

By prepaying your retired life membership now, you avoid paying more later because dues are increased. The current dues are \$435 for life.
